

Keynote Session - Strategic Leadership

We are familiar with the classic approach to strategic planning. Typically, a SWOT analysis, it is often the first step in an organization's annual budgeting process. The organization analyzes its operating environment as a critical component in establishing goals and objectives for the coming fiscal year.

In this program, we will review the standard approach used by most businesses, evaluate what works and what needs improvement, explore alternative models for establishing goals, and learn how an agency can update this process to adapt to today's rapidly evolving business environment as a care-at-home provider.

We will also explore scenario planning, in which the PEST analysis will explore the impact of political, economic, societal, and technological drivers. General Session - The Retiring RAP and the Notice of Admission Named Successor

The most significant change agencies have experienced with billing in 2021 is the timely submission requirement for the Request for Anticipated Payment (RAP) and associated penalty. The coming Notice of Admission (NOA) in 2022 is the next big issue. RAPs have no associated reimbursement in 2021 but carry a monetary penalty if not filed timely and the same will be true for the NOA. The NOA potentially carries a more significant penalty punch and agencies must be prepared. This session will review some of the key areas of concern with both and guide agencies to compliance.

- Review current claims processing issues log at the Medicare MAC and identify how agencies can track their issues
- Review statistics regarding the No Pay RAP
- Outline penalty and how agencies monitor

Detail the requirements for the Notice of Admission in 2022

- Review Claims Processing Manual for Updates
- Detail the plan of attack for agencies to succeed with NOA implementation in 2022

care and hospice professionals. Melinda routinely conducts home care and hospice reimbursement workshops for state associations across the country. Melinda has a deep understanding of Medicare PDGM, billing, collections, case-mix calculations, chart reviews and due diligence. UPIC, RA, ADR & TPE appeals with all Medicare MACs have become the forefront of Melinda's current impact on the industry. Breakout Session - Medical Review in the Home Health Medicare Certified World

This session will take agencies through the winding road of Medicare scrutiny. While billing the Medicare benefit and getting paid relatively easy, there is always a risk of things being reviewed at some point and what can you do to avoid denials. Participants will be able to define the levels of Medical Review that are currently active: including, UPIC, SMRC, MAC ADR, RAC and the reinstated Targeted Probe & Educate. The session will review how to respond to any level of medical review that may occur. This session will also discuss PEPPER reports and other data analysis that agencies will need to review to ensure that their risk from medical review is limited. This session will review some State specific PEPPER data so you can tell where you stand compared to others in the state. Don't be caught in the position of believing that everything is just okay or that the Public Health Emergency is a shield from medical review. Attendees will take away information that will assist in assuring that your home health truly is accurately documenting.

He received a B.A. in Public Health from Tufts University and an M.B.A. from the Graduate School of Management at Boston University concentrating in Health Care Finance.

General Session - Medicare Home Health Value-Based Purchasing: Focus on Quality and Financial Performance Data (Presented Virtually)

Today's care environment is becoming increasingly data-driven. Care choices by patients and potential health care provider collaborators are often made based on data that is publicly available from CMS and other sources. Value-based care models continue to gain traction in the home health industry, including the expansion of the Medicare home health value-based purchasing model, requiring a focus on quality and financial performance data. Ongoing evaluation of your data is critical to allow you the opportunity to thrive in a value-based market. This session will review key performance metrics and strategies you can use to position yourself to survive and thrive in this new world of value. (This session will be presented virtually).



Aaron Little, CPA, is the Managing Director at BKD, LLP, he has many years of experience with BKD and oversees the operations of BKD Health Care Billing Services, a special team that manages the billing and revenue cycle operations for more than 100 home care, hospice and senior living organizations throughout the nation.

A CPA and leading national home care and hospice consultant, he routinely performs revenue and accounts receivable recovery services, revenue cycle operations assessments, client training and related services. He also frequently consults with providers and legal counsel on billing and operations compliance matters, including assisting providers with compliance audits required by the Office of Inspector General and program integrity contractors.

General Session - Navigating Risk in a Post-COVID World: The Future for Home Care

The COVID-19 pandemic has created enormous change in the marketplace for post-acute and long-term care across the country and in Louisiana. This session will address the latest thinking on how the pandemic is affecting the continuum of care and look into the future to examine labor shortages, changing payor environment, new modes of care delivery, evolving regulations and consumer preferences. Takeaways will include the need to prepare for the return of value-based care, form new partnerships and proactively address workforce and consumer confidence.



Brian Ellsworth, MA, Vice President, Public Policy and Payment Transformation, has more than 35 years of experience in health care financing, delivery, and policy. He leads efforts to develop value-based payment approaches and innovative payment and service delivery models, in addition to providing COVID-19 support to operations and keeping abreast on regulatory issues. Mr. Ellsworth previously worked as a policymaker in New York's Medicaid program and at Optum (UnitedHealth Group). He has held leadership posts in state and national health care trade associations (LeadingAge New York, Connecticut Association for Healthcare at Home, American Hospital Association). He has served on numerous policy and technical advisory panels and is a respected thought leader and frequent speaker.

Breakout Session - What You Need to Know About Selling Your Home Health or Hospice Agency

Over the last year or two, there have been a remarkable number of acquisitions of smaller home health and hospice agencies by an aggressive group of venture capitalist funded buyers. This talk will focus on things a seller needs to know about selling your agency from the initial letter of intent to crossing the finish line and selling your agency for the best price and with the least amount of lingering risk.

We will talk about the due diligence process, and what to expect in a purchase agreement - including the differences between an equity acquisition and an asset acquisition. Special focus will be on a seller's representations and warranties as these are linked to a seller's indemnification obligations and the transfer of such risk to a third party through the purchase of representation and warranty insurance (RWI).



Christopher Johnston, Esq, Mr. Johnston completed law school at the Universite' de Geneve, in Geneva, Switzerland, where he obtained his basic Swiss law degree, a license en droit, in 1982. The following year, Mr. Johnston obtained a Masters of Letters and Law degree (LL.M.) from the University of Pennsylvania in Philadelphia. In 1984, Mr. Johnston moved to New Orleans where he successfully passed the Louisiana Bar examination and commenced work. In 2005, Mr. Johnston establish his own practice in Baton Rouge at the Johnston Law Firm, LLC. As a sole practitioner, Mr. Johnston continued to offer health care regulatory and transactional advice to his varied clientele. Mr. Johnston is a certified American Health Lawyers Association Alternative Dispute Resolution Arbitrator and Mediator. He is rated preeminent - AV by the Martindale and Huddle Directory.

Breakout Session - Infection Prevention and Control Update: Safely Providing Care to a Patient in the Home

While waiting for an eventual end to the pandemic, the number of new COVID-19 infections continue to surge in the United States and surveyors continue to focus on infection prevention and control activities. During this time, home care and hospice staff need to continue to keep their infection prevention and control knowledge and skills current while caring for patients in the home. This session will review infection prevention and control strategies based on the current CDC recommendations and OSHA regulations, and provide practical, best practice recommendations for preventing the transmission of SARS-COV-2 when caring for a patient in the home. Topics presented will include personal protective equipment, common compliance issues, managing equipment and supplies brought into the home, and more.

Objectives: At the conclusion of this session, the participant will be able to:

- Describe infection prevention and control strategies to protect the staff and prevent the transmission of SARS-CoV-2 in the home.
- Recognize common problems and infection prevention challenges related to providing care in the home setting.
- More effectively prepare for a focused infection control survey.



Mary McGoldrick, MS, RN, CRNI, has been a pioneer in the field of infection prevention and control in home care and hospice for over 25 years, with seminal works published on infection prevention and control for the home health and hospice industries. She began her career more than 40 years ago as a home health aide and has served in a myriad of home care clinical, management, and executive-level positions, including as a hospice volunteer. She was a home care and hospice surveyor for The Joint Commission for 12 years and has provided subject matter expertise on infection prevention and control in home care to the CDC-HICPAC, APIC, TJC, CHAP and other organizations. Mary is a frequently invited speaker on infection prevention and control topics and has provided education to tens of thousands of home health, hospice and private duty providers nationally and internationally. Mary

has authored over a hundred articles plus several books and book chapters, including the Home Care Infection Prevention and Control Program manual and the first and second editions of APIC's Infection Control in Home Care and Hospice.

Breakout Session - Preparing for the Home health Value-Based Purchasing (HHVBP)

CMS has proposed to expand the HHVBP program to all 50 states effective January 1, 2022. For those agencies not in the 9 HHVBP demonstration states, there is a lot to learn from the last five years of the demo and the new changes that CMS is proposing. Join Chris Attaya as he reviews the components that drive the model and how you should prepare for the HHVBP expansion.

- Share the five-year HHVBP demonstration model structure and significant changes
- Review the Proposed Rule (CY 22) HHVBP national expansion
- Review the statistics surrounding the outcomes and reimbursement impacts from the model

<u>Breakout Session – Infection Prevention and Control Surveillance Data: Meeting Regulatory and Accrediting Organizations' Requirements</u>

Surveillance data is an integral component of an effective infection prevention and control and QAPI program. The recent emphasis on COVID-19 has redirected the focus on infection control and preventing adverse outcomes, especially preventable patient infections. Home care and hospice organizations are often challenged by determining whether a patient infection is considered a home care-onset infection. This session will review how to conduct risk assessment activities, how to determine what types of patient and employee surveillance data to collect, how to measure and monitor infection prevention and control data, and how to implement a comprehensive surveillance program that meets the intent of the accrediting organizations' standards and home health and hospice CoP requirements.

Learning Objectives:

At the conclusion of this session, the participant will be able to:

- Describe how to establish and implement a comprehensive surveillance program.
- Integrate infection prevention and control surveillance data into a QAPI program.
- More effectively prepare for a survey under the Home Health and Hospice Conditions of Participation (CoPs) and Accrediting Organizations' standards. Presented by Mary McGoldrick

General Session - Update from Health Standards - Survey and Certification

What's the latest news about the state survey process? What will Louisiana's Health Standards team be focused on as we continue to evolve through the pandemic experience? How can your staff prepare for the significant differences in the survey teams' directives? Marian Tate has worked on and led survey efforts for licensing and certification of home health and hospice providers since 1998. This session is an important one for any and all provider staff.



Marian Tate, BSN, RN, graduated with a BS from Northwestern State University in 1982. Marian worked at Our Lady of the Lake Regional Medical Center on the Oncology Floor and the Oncology Specialty Care Unit from 1982 until 1997. She worked for a small home health agency from 1997 until it closed in 1998 due to the BBA and all the cuts. Then Marian came to Health Standards in 1998. She started at the Nursing Home Complaint Desk and then moved to the Home Health and Hospice Desk where she is happy to be today.

General Session - Home Health Final Rule 2022

The Final Rule for the Home Health Prospective Payment System, effective beginning January 1, 2022, brings more complicated and impactful changes to Medicare home health. Richard MacMillan, JD, RN, has been analyzing proposed and final rules for nearly 25 years. His insight is sought by and acted upon by providers across the country. A Past-President of the HCLA Board, Richard again presents his annual synopsis of the final rule in language providers can understand and apply to their businesses.



Richard A. MacMillan, JD, RN, is Senior Vice President/Senior Counsel, Legislative and Regulatory Affairs for LHC Group since 2007. Richard served many of the state's home care providers as legal counsel in his prior employment with the Gachassin Law Firm. He is a Past -President of the Louisiana Rural Health Association, a member of the American Health Lawyers Compliance Association. Mr. MacMillan served as General Counsel to the HCLA from 1994 to 2007. He is admitted to the Louisiana Bar and the Mississippi Bar. He is also licensed as a Registered Nurse in Mississippi and Louisiana. Mr. MacMillan received his Juris Doctorate from LSU, and a B.S. in Nursing degree from the University of Southern Mississippi.
