Data from NHPCO's Facts and Figures indicated that short length of stay for patients receiving hospice care was on the rise in the United States. Data from the NHPCO (2016) showed that 55% of patients received hospice care for 30 days or less. Data from CMS's FY2019 Hospice Wage Index final rule showed that in FY2017, on any given day in the last 7 days of a Medicare life, 42% of patients received NO skilled registered nurse or social work visits. This data is concerning from a compliance and quality of care perspective. This session will present NHPCO's Imminent Death Protocol tool and show hospice providers how to improve the quality of patient and family care in the last 7 days of life.

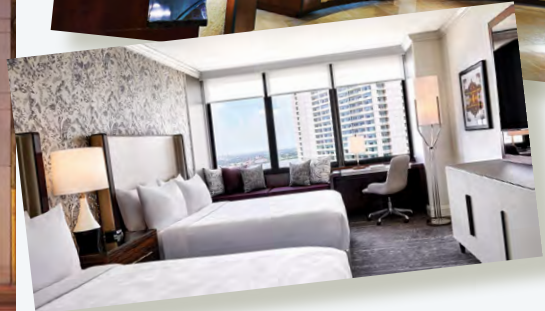
