Home Health Value Based Purchasing (HHVBP) has the potential to drastically alter the shape of the Home Health industry. This presentation will review the changes expected to clinical, quality, and financial operations under the new model, including some unintended consequences that were seen in the initial demonstration. We will provide a detailed overview of the national HHVBP expansion, walk through an example Total Performance Score (TPS) report, and address measures agencies can take now to prepare for Value Based Purchasing and provide actionable steps you take in the very near future to prepare. We will explain how an agency used their projected TPS report to drill-down in specific targets areas and develop detailed action plans for improvements their standing under HHVBP.

Health care remains high on the agenda for Congress and it's not all Covid-19. With CMS, it is a combination of business as usual and a continuing push for innovation. This program will provide an up-to-the-minute on what Congress has in mind for home care and hospice, including workforce supports, Medicaid HCBS expansion, telehealth, Medicare innovations such as the Choose Home Act, and extending Public Health Emergency waivers. It will also cover pending and expected Medicare home health and hospice rules for 2023 along with the increasing program integrity and quality of care oversight of hospices and home health agencies. These insights are an invaluable way to stay ahead.

Objectives: Identify what Congress may do to help increase the healthcare workforce both short term and long term. The Gulf States of Louisiana, Mississippi and Alabama have experienced an increase in Additional Documentation Requests from the Medicare Administrative Contractor, Palmetto GBA, since Targeted Probe and Educate resumed in September of 2021. The number one cause of denials for documentation submitted continues to be Face to Face Encounters. This session is designed to instruct attendees on how to successfully respond to an ADR request and avoid denials. A discussion of F2F content acceptable to PGBA and strategies to ensure the encounter note content is captured will be presented. Additionally, a preview of what is to come when CMS rolls the Gulf States into the RCD program for which Pre-Claim Review is a major challenge. The time to prepare is now!

Improving your agency's quality never ends, and exactly what CMS is getting at with VBP. Good should never be good enough. Use QAPI and process improvement to take your agency to the next level. A generalized approach to quality may not have the impact expected. How do we aim what it is we are doing to gain quality improvement? We will discuss a PDSA improvement project that we did and the positive results we obtained and the sustained improvement with repeats of the same process multiple times. In this presentation we will give you the steps to implement your own process improvement project.

Learning Outcomes: Identify elements of a quality improvement project, Discuss how to implement a personalized improvement project, Explain ways to improve performance in PDGM and VBP, Describe ways to objectively measure performance.

How do you prepare for an Administrative Law Judge hearing concerning a ZPIC audit that took place 4 years ago and none of the clinicians are available and the records were destroyed in last years' hurricane.
