Old Business: Meeting Minutes from April 27, 21 were approved.

New Business:

MSA offices will be open for business/meetings as of July 12. It was decided to continue MJPS Board meetings via zoom since so many would be coming from quite a distance.

As Jail Programmers, we know the impact that one person can make on the lives of those in custody. The right word, spoken at the right moment, in just the right way, can penetrate even the toughest exterior. The Dakota County Jail recently experienced the loss of one of our program facilitators who had a gift for doing exactly that. Ron Reed passed away early this month after battling cancer. He was a consistent and impactful presence in our facility for ten years. During that time, he facilitated Moral Reconation Therapy (MRT), a cognitive behavioral intervention program that allowed participants to explore their decision making by confronting their beliefs, attitudes, and behaviors and had also began facilitating Decision Points. Ron had a unique and authentic way of connecting with the individuals in his program; known for saying what needed to be said, even if it ruffled some feathers. Whenever we asked those in custody which programs at the Dakota County Jail were most impactful, it was MRT and Ron Reed that we heard over and over again. We tried to calculate the number of men in our facility that his program reached and we know it climbed well into the hundreds over the years. Sergeant Jake Schak reflected on Ron's impact, "[his] ability to transform any environment into a classroom of transformation will be missed. We want to express our deepest sympathy to the Reed family and friends." The staff at the Dakota County Jail will miss your partnership and your absence will undoubtedly be felt for years to come. It was a pleasure to know you.


