At the time of this writing, Representative Nolan West advised me that our mortgage foreclosure proposals are moving to committee and will give a status update of House File 2484 at the seminar. The proposed changes will give you guidance on what to do with overages from mortgage foreclosure sales and help to eliminate the lawsuits and settlements that have cost sheriff's offices *a lot* of money.

Many sheriff's offices have been faced with junior creditor redemptions where the junior creditors are in dispute and demand the Sheriff decide what action to take! The new legislation will remove this responsibility from the Sheriff and place it where it belongs...in the courts.
