#### **Program Updates:**

Crow Wing County Chief Deputy Andy Bradley shared information about one of their programs, Lakes Area Law Enforcement Association, which is a law enforcement help group that currently includes TRIAD members. One of the things they are looking at is whether to keep those groups combined or have a separate TRIAD program. Andy shared a lot of good information and considerations, which initiated a good discussion, that can pertain to all TRIAD programs.

Shirley stated that Aitkin has been meeting monthly since April of this year. Their Board meets monthly and they have 3 programs a year that are open to anyone. Their Sheriff cooks for the TRIAD group in July. They are a 501c3.

Carlton County hasn't met since COVID until today!

Champlin started meeting again in 2022 and have had speakers at their meetings since discussed at the last MN TRIAD meeting. Examples: \$1 bill, Medicare, Exercise, Music, AARP. Have phased away from fraud and focus more on what brings people joy. They have good luck meeting at senior housings. Champlin is in Hennepin County; however, they are not connected with the County. Kelly will talk with the new Hennepin County Sheriff at the conference. Pauline stated that Kristen Tomlinson (a Captain with Hennepin County) was planning on attending the meeting; however, she had a conflict with this meeting date. And we will list Champlin on our TRIAD contact list (That was a Secretary thing.... so sorry!!!) One question they would like to see asked at conference is "What can seniors do for law enforcement?"

Goodhue County has a speaker every meeting and their Sheriff is at every meeting and very supportive! They also have a gift card for speakers and provide treats (someone bakes!) They are a 501c3. Struggle to get new members.

Cass County has not met since COVID.

#### Minnesota and National TRIAD:

A new contact list was provided, including information on who returned their surveys. Pauline provided an overview of the information. Kelly mentioned there is good information on the National TRIAD website and how you can register your TRIAD group on there.
