# Not-As-Well-Known SCAMS

In searching for a subject for this quarter's newsletter, I went to www.aarp.org, a trusted resource... and Triad partner! I then went searching under Scams & Fraud and there's a lot of them. I would like to share some Not-As-Well-Known scams that I found information on. The information here is brief; however, the AARP website has the detailed info. Check it out!!

Some Not-As-Well-Known Scams:

- •Celebrity Imposter Scams Is a celebrity really going to be sending you a personal message?
- Greeting Card Scams –
   electronic greeting cards can
   make your day. However, if it's signed by "a friend" instead of

a real name, beware!!

- Online Pharmacy Scams The National Association of Boards of Pharmacy (NABP) estimates that 95% of online pharmacies do not comply with U.S. pharmacy laws or professional standards. Be careful!
- ●Pet Scams A 2017 Better Business Bureau (BBB) study estimated that at least 80% of sponsored search links for pet sales may be fraudulent, advertising animals the supposed sellers don't own.
- •Spear-Phishing An e-mail that appears to be from a supervisor or colleague at work makes an unusual urgent request for money or financial information. Our MN Triad Board experienced this scam when an e-mail was received by all the other Board members from one Board member saying they were in a meeting and needing gift cards purchased immediately! Easily confirmed by checking the e-mail address, but looked legitimate at first glance!
- ●Pension Poaching A financial scam targeting veterans, perpetrated by shady advisers who promise to help former service members grow their retirement funds or obtain extra benefits from the Department of Veterans Affairs (VA).

There were almost 60 scams and fraud listed under the Fraud Resource Center page of AARP. And while many have similarities, it's amazing and sad the lengths that scammers will go to. Nothing is sacred. Not funerals, not veterans, not taxes, not disasters, not pets or titles to your house. Scammers will use anything.....anything....to get information and money from you. Always take the time to check it out.... nothing is that urgent!

## Recipe

#### **Quick Taco Bake**

1 lb. Hamburger 1 env. Taco Seas Mix 1 can corn, drained 2 c. Bisquick 2 eggs ½ c. ch. Onion 1-15 oz. t. sauce 2 c. sh ched chs 1 c. milk

Brown hamburger and onion – drain. Stir in seasoning mix (dry), tomato sauce and corn. Put in 9x13 pan. Sprinkle with shredded cheddar cheese. Mix Bisquick, milk and eggs and pour over beef mixture. Bake at 350 for 35 minutes or until golden brown. Serve with sour cream, chopped tomato and shredded lettuce, if desired.
