# **Meeting Minutes**

Kelly called the meeting to order at 10:39 AM and welcomed everyone! Introductions were made and breakfast was ordered.

# **Minutes and Program Updates:**

Minutes from the last couple Zoom meetings were distributed and briefly reviewed. Attendees shared information about their programs:

Goodhue County started meeting in April and have a full schedule planned. They meet in one location.

Isanti County started up about six months again and has a full line-up of speakers. Lisa also shares crime statistics and other law enforcement and safety information at their meetings. They usually meet in the same location. They average 20-30 people at their meetings.

Aitkin County has just started meeting. They move their meetings around the county. They have 3 programs per year. Champlin has been meeting quarterly and now they will be meeting monthly. They average 15-25 people, sometimes up to 35 when speakers.

Carlton County is not meeting yet. They move their meetings around the county.

Cass County is not meeting yet. They meet in one location.

Brown County is not currently active. They move their meetings around.

We talked about the number of Triad programs in Minnesota and the importance of getting all counties involved in this vital program that enhanced senior safety. We also talked about how more populated counties, especially those like Hennepin that have bigger Police Departments, may have more than one Triad program. Need law enforcement for a Triad program; however, it can be Sheriff's Offices or Police Departments. Discussion about other Police Departments that have Triad programs.

# **Treasurer's Report:**

Treasurer's Report was distributed and reviewed by Mickey. All agreed that the format was very informative and complete. Our balance is higher because of the money we've received from AARP for the Webinars. We do not have a plan for the money; however, we have not done fundraising on a state level to build it up other ways. We would still like to do a cookbook. ## 501c3:

Goodhue County has decided to keep the 501c3. There was discussion on which counties have a 501c3 (only Goodhue and Crow Wing that we're aware of). Counties are able to accept monies as a non-profit, as well as other organizations that will allow Triad to be under their umbrella (ie. Senior Centers). Do not have to be a 501c3 to accept monies; however, some organizations need that when donating money. Kelly will talk to Bill Hutton, the Minnesota Sheriffs' Association Executive Director, to see if we are still able to use their 501c3.

# **Update your Triad Information!!:**

## **MN Triad Conferences:**

Goodhue County is already working on planning the 2023 Conference! Thank you, Goodhue! We discussed the option of the motel separate from the conference venue, but all agreed it works much better for people to be able to stay where the conference is being held.

We discussed the possibility of an in-person conference this year instead of a Webinar. After much discussion, it was decided that there wouldn't be enough time to plan a full conference. Other options are still being explored, including a possible collaboration with AARP. Pauline will reach out to Jay Haapala at AARP and see if there would be any possibilities there.

# **Information Sharing:**

Kelly thanked Pauline for all her work on the newsletter. Pauline thanked Mickey for handling the recipe section!! We will put out reminders on Facebook of the MSA Triad website link and re-sent out with the minutes. A reminder that we are always looking for Featured Members and submissions regarding what your Triad group is doing.
